### 1. The Agreement

### 1.1. Parties

This agreement is made as of this day (see Signature) between:

- (1) Swedish Chamber of Commerce in China, a non-profit member organization in the People's Republic of China (the "Chamber", "SwedCham"); and
- (2) The company name i., a company incorporated in China whose registered office is at XXXXXXX (the "Company")

### 1.2. Intent of Agreement

The purpose of this agreement is to define the sponsorship engagement between the Company and the Chamber with regard to its Swedish After Work and leading up to Event date.

### 1.3. Content

The following services shall be provided by the Chamber to the Company upon successful completion of the present agreement.

- The *Company* name and logotype exposed in all advertisement of the event.

- The Company is given the opportunity to present itself during the event. ( About 10 minutes )

### 1.4.Schedule of fees

The company agrees to pay a one-time charge:

(The price includes the service fee for SwedCham, and costs of snack and beverages, in total covering 30 attendees. For additional attendees, a fee of RMB 200 per person will be charged. The additional fee will be paid by the company on the day of the event. )

#### At Hotel/Bar: Member: 13,000 RMB; Non-Member: 26,000 RMB

(The price includes the service fee for SwedCham, potential venue rental, and costs of snack and beverages, in total covering 30 attendees. For additional attendees, a fee of RMB 300 per person will be charged. The additional fee will be paid by the company on the day of the event. )

### 1.5. Cancellation Policy

If the *Company* cancels the event less than 30 days prior to the event, the fee is non-refundable.
